I am aware of the need to have an adequate travel medical insurance for my first stay and any subsequent visits to the Republic of Croatia/我知道首次入境或随其后任意一次入境克罗地亚共和国，都需要提供充足的旅行医疗保险。

I am aware of and consent to the following: the collection of the data required by this application form and the taking of my photograph and, if applicable, the taking of fingerprints, are mandatory for the examination of the visa application; and any personal data concerning me which appear on the visa application form, as well as my fingerprints and my photograph will be supplied to the relevant authorities of the Republic of Croatia and processed by those authorities, for the purposes of a decision on my visa application/ 我知道并同意如下：签证申请表格所需填写的资料，提交的照片，或需采集的指纹均为签证申请所必须的。签证表格中所有关于我个人的资料，照片及指纹将被提交，供给克罗地亚共和国相关的部门，并由其受理我的签证申请作决定。

Such data, as well as data concerning the decision taken on my application or a decision whether to annul, revoke or extend a visa issued will be entered into, and stored in the Visa Information System of the Republic of Croatia (HVIS) for a maximum period of five years. During that time all data will be accessible to the visa authorities and the authorities competent for carrying out checks on visas at external borders and within the Republic of Croatia, immigration and asylum authorities in the Republic of Croatia for the purposes of verifying whether the conditions for the legal entry into, stay, and residence on the territory of the Republic of Croatia are fulfilled, of identifying persons who do not or who no longer fulfil these conditions, of examining an asylum application and of determining responsibility for such examination. Under certain conditions the data will also be available to designated authorities of the Republic of Croatia and to Europol for the purpose of prevention, detection and investigation of terrorist offences and other serious criminal offences. The authority responsible for processing the data is the Ministry for Foreign and European Affairs of the Republic of Croatia./ 该信息以及签证结果甚或签证注销、撤消或延期的决定将一并收录到签证信息系统（HVIS）并最长保存五年，在此期间，克罗地亚的相关签证部门、边境及境内的签证检查部门以及移民局和难民局均有权登陆系统，核查签证申请人是否已满足入境克罗地亚并在境内逗留，居住的相应条件，核实不满足或不再满足该条件的申请人，审核难民申请并确定该审核的责任。必要时，克罗地亚的特定部门和欧洲刑警组织有权参考该信息用于预防、侦查和调查恐怖袭击活动及其它严重犯罪行为。负责处理信息的部门是克罗地亚共和国外交和欧洲事务部。

I am aware that I have the right to obtain notification of the data relating to me recorded in the HVIS and to request that data relating to me which are inaccurate be corrected and that data relating to me processed unlawfully be deleted. At my express request, the authority examining my application will inform me of the manner in which I may exercise my right to check, correct or delete if inaccurate or illegally processed, any personal data concerning me in HVIS, as well as of the legal remedies according to the law. I declare that to the best of my knowledge all particulars supplied by me are correct and complete. I am aware that any false statements will lead to my application being rejected or to the annulment of a visa already granted, and may also render me liable to prosecution under the law of the Republic of Croatia./ 我申明就我所知提供的所有信息都是正确完整的。我知道任何虚假错误信息都将导致我的签证申请被拒签或吊销已签发的签证，并可能按克罗地亚共和国法律使我受到法律诉讼的后果。

I undertake to leave the territory of the Republic of Croatia before the expiry of the visa, if granted. I have been informed that possession of a visa is only one of the prerequisites for entry into the Republic of Croatia. The mere fact that a visa has been granted to me does not mean that I will be entitled to compensation if I fail to comply with the relevant provisions of the Aliens Act of the Republic of Croatia (Official Gazette, No. 133/20) and I am therefore refused entry. The prerequisites for entry will be checked again on entry into the territory of the Republic of Croatia./我保证如果签发签证，就在其逾期之前离开克罗地亚领土。我已被告知得到签证只是进入克罗地亚共和国的先决条件之一。仅仅发给我签证这个事实并不是说如果没有遵守克罗地亚共和国侨民法(政府公报. 第 133/20 号)的相关条款并因此被拒绝入境，我会因之有权利要求补偿。在进入克罗地亚领土时，入境条件将再次被核查。
